



Renovations

- The plan is to plant Bermuda grass around the building early next summer.

Other Project

- Both HVAC units in the auditorium need repaired.

CARES Grant

- We are applying for reimbursement for Covid related expenses:
 1. Clean supplies
 2. PPE
 3. Online instruction

Total reimbursement will be \$84,196.02

Elementary Principal's Report
October 12, 2020

- Enrollment is 23~~5~~⁴
- Fifth/Sixth football is undefeated. They play their last game next Monday in Boise City.
- The week of October 26th is the Forgan Tournament which kicks off elementary basketball.
- Tomorrow evening is parent-teacher conferences. We are limiting to people we need to see. Many of the teachers are doing phone and zoom conferences.
- I have been working on the Fall Accreditation Report and have completed it.
- Covid Challenges:
 - o We have had 58 people quarantined. 39 have now returned.
 - o We have had 4 students test positive-3 have returned.
 - o We have had 13 staff members quarantined (3 work in both buildings). 8 were positive tests, and 7 have returned.
 - o We had two subs who had to quarantine. One has returned.
- Overall, this has been a successful first quarter. Teachers have worked together through the challenges and have maintained positive attitudes.
- I will have elementary basketball games next month and will not be able to attend the board meeting.
