The Meeting was called to order by Amy Hugill, President at 7:00 p.m.

Motion by Peter Shatrawka, Second by Tadd Owens to move to Executive Session @ 7:02 p.m. pursuant to Wisconsin Statutes 19.85 to consider employment, promotion, compensation, and consider specified public business matters, which the governmental body has jurisdiction or exercises responsibility.

The board returned to open session at 7:30 p.m.
