 - 1. Financial Reports

Jefferson Braman, Business Administrator, spoke about the following: CARES ACT, NHSAA Carl Ladd presented to the governor the possibility of receiving \$200 per student totaling approximately \$184,000, adjustments to be made to offset the increased taxes, MS 22, tax rate set up, revenue reports and projections, Adequacy formula, Free and Reduced additional funds, etc.

The second part will be for technology apps, anonymous reporting, mentoring and response system.

7. Snow Days/Remote Learning

Discussion was had with the teachers regarding holding remote days rather than snow days. We are working on an MOU with the attorney. This may be affected if there are internet or power outages, etc. This is different than a blizzard bag.

8. Thanksgiving/Christmas Calendar Discussion

Discussion was held regarding options for Thanksgiving and Christmas breaks. There are concerns surrounding people traveling and spending time with family outside of New England. An anonymous survey will be sent out everyone to get an honest feel for what people are doing to make an educated decision. There concerns regarding how to handle this and coverage.

9. APPTEGY Demonstration/Launch

There continues to be more training. Other topics discussed were emergency notifications, mobile app, ability to link to multiple locations at one time. Jule Finley gave a live overview of the website. There is still more work to be done. This will be going live at the end of the month.

6. Curriculum Report

Jule Finley, Curriculum Director, gave an overview of the following: Demonstrated Success, Online Training to Survive and Successes through this Unique Situation (with posters in the building and recorded for future), Teachers Pay Teachers, Mentoring Program, Pennell, ZERN, PSAT/SAT Testing, NHSAA items, Simple K-12, Google Classroom, and Kids Production with ZOOM rehearsals. There was a question as to whether or not there would be any additional cost for next year for Discovery Ed and Teacher Pay Teacher.

7. Student Representative Report

Kolbe, FHS Student Representative gave a report about making this year's homecoming ZOOM friendly and continue to follow the mandated guidelines and include small games throughout.

8. Special Education Report

Rebecca Butt, Special Education Director, spoke about Compensatory Education Meetings, DOE Special Education Weekly ZOOM meetings, NHSEIS Online Tracking, no cost expended yet, some students are coming in four days per week (28 students so far including Life Skills and Odell students), PANDA Doc for signing forms, the special education enrollment is 250, and we lost many students to be homeschooled.

Susan Blair, PSS Principal, gave an overview of the following: the extraordinary things happening throughout the school, technology glitches and improvement, the nurses collaborating together during all aspects this year including contact tracing which takes much time, energy and hard work, there is a shifting of population, trying to meet the
