2. Assistant Superintendent's Monthly Report:

- Assistant Superintendent Parsons gave an overview of her activities for the month. Highlights included:
  - Began gathering information regarding the progression of World Language instruction and of Music/Strings
  - Continued discussion at GMMS around impact of scheduling on curriculum
  - Supporting teachers and administrators in preparing for hybrid and remote models
  - $\circ$  Planned and implemented Professional Development for November  $3^{\text{rd}}$
  - o Initial review of distance learning and a drug and alcohol policy
  - o Planned for Waking Up White Book Club
  - o Continued work with the CSDE and DPH around monitoring Covid-19
- 3. Draft policy 4000.1 Title IX Personnel:
  - Discussed the Title IX policy and made a few edits to the recommended policy. Rosemarie Weber moved that Policy 4000.1 Title IX Personnel, be forwarded to the full Board with changes discussed. Brandon Webster seconded. Motion passed unanimously.
- 4. Draft Policy 5145.44 Title IX Students:

- 6. New Course: Natural Disasters (Science, Grades 10-12)

    history of adding the course and the committee would like to look at the
    department holistically at the next meeting.

would assist with class placement in the High School and would align with
SAT work.
