

Schley County Virtual Learning Program Application for Spring, 2021

The Schley County School System will offer an option for students to participate in our Virtual Learning Program for Spring Semester, 2021. Schley County Schools will continue the Edgenuity Online Curriculum for students who choose to receive instruction from home. **Only virtual students that successfully completed courses during the fall semester are automatically eligible, provided that all requirements were met, including but not limited to consistent daily participation as evidenced by the user's activity log.**

Families continuing with this option must remain in the Virtual Learning Program for the entire 2nd semester. Completion of state-mandated testing will be in person at the site designated for the grade level and course.

Parents or guardians must return their intent letters for continuing virtual instruction **no later than 4:00 pm on December 4, 2020.** If the application is not received by this date, the district will assume that your child(ren) will be participating in face-to-face instruction beginning January 5th. The applications should be printed, completed, and emailed to wildcathelp@schleyk12.org or hand delivered to the Board of Education office (between the hours of 8am-4pm).

If registering more than one child, please complete a separate application for each child.
