Congratulations to the Boys & Girls golf teams as they both finished their season at the District level. As Mrs. Coleman mentioned, the Football team is in the second round of the playoffs and Volleyball will begin their tournament run on October 22nd.

The HVAC replacement should be completed within the next couple of weeks. The window replacement is completed at the Elementary and the High School is in progress. Teachers at the elementary have complemented that their rooms have less traffic noise and the air condition units have worked nicely and are quiet.

Warren Local will be auctioning off furniture. We will be checking into what they have to offer and may purchase a few items.

Mr. Baldwin asked the Board for guidance on where to make more improvements once the HVAC and window project is done. Things we may consider: pole replacement at the football field, electric upgrade in the High School, upgrade to the lift station.

Southeast Ohio Broadband Cooperative Exploratory is asking families in the area to do a speed test with their internet service. They need at least 3,000 households to do this test in order for the State to understand the need in the area. Mrs. Coleman was putting something together to inform our District families the need to participate in this test.
