There was discussion and questions from those in attendance regarding the remote learning situation. Supt. Moore's recommendation is to close the school to remote learning from Tuesday, November 10 through Monday, November 16, 2020. It was also discussed that all Junior High Basketball practices would be cancelled for the week as week. Supt. Moore stated that the teachers were responsible for attendance and the input into Infinite Campus. He stated that these are regular instruction days. Supt. Moore also stated that Friday, November 13, 2020, will be an instruction day to keep the four day week consistent. School meals will be available to all students and could be delivered if needed. Notice will be sent out to all parents to notify the office if meals are wanted. Supt. Moore stated that hopefully with acting fast with the closure of school, the exposure to the students and staff will be minimal. He stated if the staff has any questions to please contact him.

A motion was made and passed unanimously to approve remote learning November 10th through November 16, 2020. **Taylor/Myllymaki**Motion carries
