

PARK COUNTY SCHOOL DISTRICT No. 6
Special Board Meeting
July 14, 2020

The Board of Education of Park County School District No. 6 met on July 14, 2020 at 12:00 p.m. in the Westside Annex Board Room. Chairman Nelson called the meeting to order and led the Pledge of Allegiance. Board members present: Stefanie Bell, Tom Keegan, Brandi Nelson, Cathy Roes, Jenni Rosencranse and Karen Schipfmann. Absent: John McCue. Administrators present: Peg Monteith. Directors present: Dawn Solberg.

Chairman Nelson called for approval of the agenda.

Tom Keegan moved to approve the agenda. Karen Schipfmann seconded. Motion carried and the agenda was approved.

Chairman Nelson stated the budget hearing would begin at 12:05 p.m. and asked if anyone had questions. There were none.

At 12:05 p.m. the public hearing on the budget opened.

Mrs. Solberg reviewed the 2020/2021 proposed budget of \$41,533,888.00 consisting of revenue, expenditures, special revenue fund, capital construction fund, depreciation reserve fund, food service fund and cash reserves. Trustee Roes asked if the second school resource officer was included. Mrs. Solberg stated it was budgeted under contracts. Stefanie Bell asked if textbook purchases had come from the 2019/2020 budget year. Mrs. Solberg replied that the majority had been paid from FY2019/2020.

The budget hearing concluded at 12:18 p.m.

Chairman Nelson called for approval of the 2020/2021 district budget.

Cathy Roes moved and Stefanie Bell seconded to approve the 2020/2021 budget appropriate and levy resolution of \$41,533,888 total appropriations and stated,

WHEREAS, on the 14th day of July 2020, the budget officer filed with the Board of Trustees of Park County School District no. 6 a proposed budget and budget message for the fiscal year ending June 30, 2020, and

WHEREAS, notice of such budget hearing was published in the Cody Enterprise, a newspaper having general circulation in Park County, the county in which the district is located, on July 7, 2020, and

WHEREAS, a public hearing was held concerning such budget on the second Tuesday in July at 12:00 noon, at which time all interested parties were given an opportunity to be heard.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Park County School District No. 6 that such a budget as revised, if applicable, is hereby adopted and, subject to future amendment, is in effect for the fiscal year ending June 30, 2021.

Trustee Rosencranse asked if there had been any public comment received. Chairman Nelson replied the meeting was open to the public and that she was unaware of any comments received. Motion carried.

There being no further business to come before the board, on motion by Tom Keegan, seconded by Cathy Roes and carried, the meeting was adjourned at 12:20 p.m.
