School Learning Model Decision - EGF ISD 595 has officially transitioned to the distance learning model for all grade levels and early reports seem to be positive. Everyone involved in the process has worked very hard and made sacrifices in order to do what is best for our children. There are numerous factors to consider when deciding on the best learning model for the students and pivoting to distance learning was a very tough call for district officials. The District's short-term goal is to bring all students back to school in model two (In-Person for Grades PK-5 and Hybrid for Grades 6-12) on Monday, December 14, 2020. A special school board meeting will be held remotely via Zoom at 5:30 p.m. on Tuesday, December 8, 2020 to determine if the original goal of coming back to school on December 14, 2020 can be met or if the distance learning period should be extended through the holiday season
