Applications and attachments must be received by **4:00 pm on February 11, 2022**. Scholarship interviews will be held on **March 9, 2022** at Defiance College and all eligible applicants are required to participate on that day in order to be considered for the scholarship award. Additional information will be mailed to the applicants prior to that date regarding specific interview times.

## Gertrude Studer Memorial Scholarship Details

### PURPOSE:

The following scholarship award program is offered by North Western Electric Cooperative, Inc. (NWEC) and awarded by Edgerton Area Foundation in memory of Gertrude Studer. She spent her entire life in rural Edgerton in homes serviced by North Western Electric Cooperative. Gertrude is credited with attending every annual meeting of the cooperative since its inception. She also loved attending the Williams County Fair and was involved in the local 4-H and FFA organizations throughout her life.

Gertrude passed away in February 2017 at the age of 109. The Gertrude Studer Memorial Scholarship was created to encourage and reward rural Williams County students who have been involved in the 4-H and/or FFA organizations and who have committed themselves to the pursuance of further training and education while also offering the students an opportunity to become more aware of careers available in a rural electric cooperative.

### SCHOLARSHIP AWARD:

One winner will receive a \$500 cash award. The award is non-renewable. The disbursement of the award will be administered by Edgerton Area Foundation.

### RULES:

To be eligible for the Gertrude Studer Memorial Scholarship award, the following provisions will govern the acceptance of applicants:

1. Applicants must be the son, daughter or legal ward of a permanent residential NWEC member-owner receiving service for the duration of the 2021 - 2022 academic year (August 2021 – June 2022). Children/wards of NWEC'S commercial member-owners are not eligible unless one of their parents/legal guardians is also a permanent residential NWEC member-owner.
2. Applicants must be a permanent resident of Williams County and attend a high school located within Williams County.
3. Applicants must have a cumulative grade point average of **3.0 or above** on a 4.0 scale.

### RULES (cont.)

4. Applicants must actively be involved in a local 4-H and/or FFA organization.
5. Winners must provide proof of enrollment in an accredited college or proper vocational/technical school of the student's choice to claim their scholarship. Winners, who are accepted and then enrolled in an accredited school of nursing, working toward a degree, are also eligible.
6. Members of the immediate families and persons residing in the households of trustees or employees of NWEC are not eligible to participate in the competition.
7. Applications must be submitted on forms provided by NWEC or downloaded from [www.nwec.com/scholarship-programs](http://www.nwec.com/scholarship-programs) and must be submitted to the NWEC office by **4:00 pm on February 11, 2022.**
8. A short essay is required that explains how the applicant's involvement in 4-H and/or FFA has enriched their lives, assisted in the development of their personal character and enabled him/her to succeed. The essay must be at least 800 words and must be typed, double-spaced. Guidelines are attached to this document.
9. Application information must be confined to the official application form with no attachments other than grade transcripts and the required essay.
10. Applicants who receive "full-ride" scholarships (i.e., scholarships that cover the cost of tuition, room, board and books) to the schools of their choice are not eligible for scholarships from NWEC.
11. All scholarships must be accepted in the first academic year following the student's graduation from high school. However, an extension of one year may be granted for just cause in the judgment of the President/CEO of NWEC. In the event students are unable to fulfill their enrollment obligation under this program, the award is forfeited.
12. Applicants are not permitted to bring any outside materials to their interviews (e.g., electronic presentations, props, handouts, etc.).
13. All rules stated within this document conform to the policies and program guidelines as set forth by NWEC.
14. These rules (dated hereon) supersede all previous rules for this scholarship.

### JUDGING:

The judges, following personal interviews with each eligible applicant, will score up to a maximum of:

- 40 points for personal interview with the judges relating to poise, personality and appearance.
- 20 points for scholastic record.
- 15 points for essay (clarity of subject, spelling and grammar).
- 15 points for community involvement, participation in 4-H and/or FFA activities and personal achievement.
- 10 points for cooperative knowledge, based upon an online training course which can be found at [www.ohioec.org/orientation](http://www.ohioec.org/orientation). A transcript of the course can be downloaded for study purposes once you have completed the course online.

Each applicant must submit a short essay describing how the applicant's involvement in 4-H and/or FFA has enriched their lives, has assisted in the development of their personal character and has contributed to their ability to succeed. The suggested outline will answer the following points:

- Why did you join 4-H and/or FFA?
- What types of activities have you been involved in since you joined?
- What specific goals as a part of the organization have you achieved and how did you achieve the goals?
- Why do you think your involvement in the organization will help you to succeed at college/vocational/technical school?

The essay must be at least 800 words and must be typed, double-spaced. Please place your name and address at the top of each page.
