RESOLVED, that Michelle Vap, Treasurer and/or Brady Barnes, Superintendent, be, and the same here by is/are, authorized, empowered, and directed to sign, on behalf of Lessee, the Lease Purchase Agreement and any addenda, schedules, notes, UCC Financing Statements, or other instruments issued under the provisions of the Lease Purchase Agreement and any other document or instrument which may be necessary or expedient in connection with agreement upon or fulfillment of the provisions of the Lease Purchase Agreement.

FURTHER RESOLVED, that pursuant to Section 265 (b) (3) of the Internal Revenue Code of 1986, as amended, the Lease Purchase Agreement shall be and is hereby designated a "qualified tax-exempt obligation" includable within the ten million dollars of aggregate issues designated as "qualified tax-exempt obligation" for the calendar year during which this Lease Purchase Agreement is entered into by Lessor and Lessee.

FURTHER RESOLVED, that Lessee shall not designate more than ten million dollars of tax-exempt obligations during the current calendar year as "qualified tax-exempt obligations," and Lessee, together with its subordinate entities, does not reasonably expect to issue more than ten million dollars of tax-exempt obligations during the current calendar year.
