### Reports

#### **IMESD Talking Points**

Superintendent L.C. reported that Oregon Department of Education released an update to its Ready Schools, Safe Learners guidance. She reviewed the updated COVID metrics which provide increased flexibility for school districts. It was noted that we can continue with inperson instruction through January 4th as long as we don't have multiple cases in multiple cohorts.

#### **Maintenance/Transportation Report**

Mike Campbell reported that he has installed cameras in the bus garage and they seem to be working properly.

#### **Principal/ Activity Report**

Mr. Mills reported that the FFA held their first Trip Tip drive-thru dinner on October 30<sup>th</sup>. They sold 310 dinners and are hoping to make this an annual event. The FBLA chapter expressed their appreciation last week to Veterans with an appreciation drive-thru breakfast consisting of cinnamon rolls and a thank you card.

High school boys and girls basketball began conditioning and skill development workouts last week. Jr. High basketball will begin this week. The OSAA Executive Board is meeting on December 7<sup>th</sup> and everyone is hopeful for the season to progress.

Mr. Mills reported that 30 out of 36 students attended Friday school this past week. 15 Juniors were also here throughout the day giving their senior project proposal speeches. He stated that teachers have said that Fridays are working out to be a great opportunity to work one on one with students and giving them an opportunity to get to know them better in the welcoming and relaxed atmosphere.

### **Superintendent Report**

Superintendent Lakey-Campbell reported that the elementary fund raiser brought in a total of \$14,626 earning PAC \$5,851. The District received a Farm to School grant for \$773 which will be used to purchase beef for the food program.

Superintendent L.C. reported that there was another executive order announced today but it doesn't effect schools. The county's two-week pause was a bit of a scare, but we are fortunate to be able to continue to be in-person. If the county numbers continue at their current levels, we will have to transition to distance learning in January. Kaiger Braseth asked if the Board and administration could take a pro-active approach and reach out to local leaders and state government to request to remain in-person. Superintendent L.C. stated she will compose a letter for the Board to sign and encouraged the members to reach out to local leaders and others to express their concern with CDL.

Superintendent L.C. informed the Board that Nathan Bingaman continues to work on upgrading the sound system in the high school gym. Plywood has been donated by Boise Cascade/ Woodgrain and he and Mike Smith are preparing to begin purchasing equipment in the next couple of weeks.
