A. 8th Grade Science Class – EHEMS – Renee Reed

Ms. Renee Reed, East Hardy Early Middle School Science Teacher, gave a presentation on the 8th grade science class fieldtrip. Thirty-nine students and seven chaperones went to the Shenandoah River with River and Trail Outfitters. The students crossed over six miles in the river during the exposition. During the river quest field school, the students were exposed to at least thirty-five educational standards ranging from science, physical education, health, history, agriculture and counseling. Students learned about the Chesapeake Water Shed and the importance of how it effects the communitee. Students also were taught the effects that we have on the bay and how we can help preserve the water.

Ms. Caitlyn Ward and Mr. Camden Link, 8th grade students, shared with the Board what they learned on the fieldtrip. Some examples were; teamwork, canoeing, what a watershed does, how we effect the rivers, and how the water was clear in the 1800's and how it has changed overtime.

The Heishman Foundation Grant helped to fund this fieldtrip and made it possible for the students with little cost.
