Ms. Nancy Hahn had concern with the effort teachers were giving calling and contacting students and helping students. Ms. Van Meter stated if any problems were brought to her attention she was addressing them as she received them.

Mr. Jerry Yates asked about the return rate of student packets. Ms. Van Meter stated each school only had 2-3 not returned and some were returning them with the second packet.

Mr. Jerry Yates asked what are the number of student food packages being distributed at this time and if any of the food purchased prior to students being off was being utilized. Ms. Van Meter stated today Moorefield Elementary School distributed 748 packages and she had not received East Hardy Early Middle School's numbers. Ms. Van Meter stated the cooks at the schools were packing 50 packages per school each week to use the food and some was given to EACHS and the Committee on Aging.

Ms. Sheena Van Meter updated the Board on the following:

Strawberries will be purchased one time in May to be distributed with meal packages on a first come first serve basis until gone.

Thanksgiving break will be observed November 23-28, 2020.

An inventory system was purchased in the amount of \$3,700 dollars to be used to inventory tools and parts. Ms. Bean asked if this system could be used to scan and inventory supplies and consumable products. Ms. Van Meter stated she wasn't sure how that would work but she would get a copy of the orders from each school and provide them to the Board.

Mr. Douglas Hines stated we did receive the National Forest money. Ms. Van Meter said the amount was \$56,000 dollars.
