# JEFFERSON COUNTY NORTH SCHOOLS UNIFIED SCHOOL DISTRICT NUMBER 339 MINUTES OF THE REGULAR MEETING OF THE BOARD OF EDUCATION OF USD 339 HELD ON NOVEMBER 9, 2020, AT THE DISTRICT OFFICE WINCHESTER, KANSAS

<u>Principals Report:</u> In addition to his written report, Matt Stapp reviewed the success of the Parent/Teacher Zoom conferences and the Halloween Parade. He reported that there are currently 21 students learning remotely.

In addition to his written report, Joe Worthington added that there are 30+ students learning remotely at the high school level including current quarantined students. All fall sports were able to finish the season. Scholars Bowl has been a challenge with quarantines. Plans are being made for an alternate HS band/vocal concert. Hosting Sub-state volleyball was successful.

<u>Superintendents Report:</u> In addition to her written report, Mrs. Jennings updated the board on food service staffing. Bus drivers and custodians are helping to cover hours from staff being off. Mrs. Jennings discussed not using snow days as remote days unless we have a shortage of hours later in the winter season. Bus repairs and EMS heating repairs were discussed.

## **Old Business:**

COVID Update: Mrs. Jennings updated the board on the COVID situation at the schools. There will be free lunches through June 30, 2021. Mask wearing has reduced necessary quarantines of students/staff. The board adopted a threshold of 2.5% of cases/quarantines – circumstantial of each situation - before changing the school status from green level to yellow/orange level based on the approved re-opening plan. The board, by consensus, chose to leave the fitness center closed during the current COVID concerns. KSHSAA will soon issue fall/winter sports guidelines.
