#### Comments from the Board

Ms. Smith asked what the District's plans were for after school care/programs. She also expressed her concern regarding the structural issues at the Sylvan Hills Jr High campus and the possibility of those 9th grade students moving to the high school campus. Ms. Smith stated that she would like that to be a priority for the upcoming school year. Additionally, she inquired about the Board meetings being held at District school buildings in the future.

Mr. Keller reiterated that Student Nutrition's work with Chartwell seemed to be going well. He stated that students are fully engaged as the results are speaking for themselves. Mr. Keller thanked Dr. Smith for her passionate work and for speaking the truth and having the right intentions. He then thanked the Board for their time and gave accolades to Security Officer Thomas at Sylvan Hills for her awareness regarding an incident earlier in the day.

#### **Superintendent's Comments**

Dr. McNulty answered Ms. Smith's question about after school care by stating that there had been a disengagement with DHS (Department of Human Services) requirements and salaries to fill the positions. He stated that the District will be meeting with a third party to discuss services and hopefully take care of the issues we currently face. Dr. McNulty informed the Board that the ACT Aspire State assessment test will be given this month and that the District has high expectations for students. He shared that professional staff have the support of District office staff. Dr. McNulty then shared that he was excited about the timeline of the facilities projects. He shared that community meetings were taking place and that the meeting for College Station Elementary school scheduled for the next day was postponed due to the threat of severe weather. Dr. McNulty closed by thanking the Certified and Classified PPC Committees for advocating for students all the time under the leadership of Ms. Robinson and Mr. Chesterfield. He shared that Mrs. Shyrel Lee, Cato Elementary Principal, was retiring this school year and thanked her for her service.
