## FAMILY (PARENT) ENGAGEMENT PLAN 2023-2024

**Sherwood Elementary** Faculty and Staff will collaborate with parents and utilize the state standards, R.I.S.E.(Reading Initiative for Student Success), AVID (Advancement Via Individual Determination) and PBIS (Positive Behavior Interventions and Supports) strategies to create an environment that achieves equity, ensures excellence for all students, and prepares students for college and careers.

In an effort to accomplish this goal of Sherwood Elementary, the school is committed to involving teachers, parents, community members and students.

**Sherwood Elementary School** agrees to implement the following statutory requirements:

- Sherwood Elementary School will put into operation programs, activities and procedures for the involvement of parents with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). - E. The resource teachers will meet with appropriate staff members to discuss modifications and I.E.Ps.
- **F.** Teachers will share students' progress and data during the parent/teacher conferences. The parent and teacher will collaborate to develop the remediation plan for the students scoring below the proficient ranges in the 5 math strands.
- **G.** Review, evaluate and revise the School Improvement Plans and discipline summary by analyzing behavior documents, parental involvement and teacher data to determine the program/planning effectiveness.
- **H.** Provide a survey to all parents to evaluate and determine parent needs, perceptions and opportunities to increase parental involvement at Sherwood Elementary.
- 3. The **Sherwood Elementary School** will provide the following necessary coordination, technical assistance, and other support to assist with Title I, Part A in planning and implementing effective parental involvement activities to improve student academic achievement and school performance:
