# 2.0 PTO Meetings

- 2.01 Comet Participation Team (PTO)/Senior Moms and Supporters meetings will take place on the campus of Mills High School the once per quarter or as needed. # **6.0 Ways to Involve Parents**

- 6.02 Parents are encouraged to participate in shared decision-making opportunities and efforts.

#### 7.0 Activities and Conferences

- 7.01 The school will host two (2) annual Parental Engagement events;
  Transitions Day for new students and rising 9th graders and The Comet
  Meet and Greet (Open House) at the beginning of each school year.
- 7.02 Parent/Teacher Conference days are set by the District. Faculty and staff are expected to participate in these events. Parents will be notified in a timely manner via call-outs, email, and postings on the District and school websites and social media.
  - 7.03 Additional Parental Engagement activities will include a minimum of two
  - (2) nights; one in the Fall and one in Spring. Participants will be provided with information about testing dates and strategies to assist their students in preparation, activities and organizations operating within the school, anti-bullying and suicide prevention information, a well as many other topics. Refreshments will be served and information will be presented about the next steps to implement school improvement individually and collectively.
