## Board Meeting Minutes of 06-15-2023

The Lamesa Board of Trustees met in a Regular Meeting on Thursday, June 15, 2023 in the Board Room.

President Rebecca H. Gonzales called the meeting to order at 6:01 p.m.

Mr. Lumbreras gave the invocation.

No one signed up for public speaking.

There was a moment of silence for the passing of Stephanie Brown and the husband of Nancy Spraberry, Paul Spraberry.

CFO Ron McBee gave a brief Financial Report. Supt. Ritchey stated the family of Kurt Pierce asked to make donations to LISD in lieu of flowers. This money will be given back to a student/s for a scholarship. McBee stated there was only one bid for bank depository renewal. LISD will be up for bank depository renewal in 2025. Joyce Trevino, Gary Pope and Charlize Pierce gave a brief Child Nutrition Presentation.

Superintendent Ritchey gave a brief overview of the LOCAL Update 121: CCGB, CFB, CKE, CKEC, CLB, CRF, CVA, CVB, DEA, FD and FFI. He stated most of the policies have minor changes either with a word or a phrase. Ritchey introduced SRO Eddie Rocha and Chief Police Josh Peterson. They are very pleased with the working relationship that the Lamesa Police Department and LISD have with each other. It is a benefit to the whole community.
