Fair Housing Laws: Know Your Rights

Federal Fair Housing Act Protected Classes

Federal law makes it illegal to discriminate in housing because of:

Race – A person's race or the race of persons with whom one associates.

Color – A person's skin color.

Sex – A person's sex, including sexual harassment or intimidation.

National Origin – The country of one's birth and/or the nationality of one's ancestors.

Religion – A person's religious beliefs or denominational affiliation.

Disability/Handicap – A physical or mental impairment that substantially limits one or more major life activities.

Family/Familial Status – Household composition, including the presence of children.

Wisconsin Open Housing Law Protected Classes

State law includes all federal protections, plus the following additional classes:

Age – Persons 18 years of age and older.

Ancestry – The country of one's birth and/or the nationality of one's ancestors.

Marital Status – Married, single, divorced, widowed or separated.

Lawful Source of Income – A person's legal means of income, including such subsidized forms as Social Security, Food Stamps, Unemployment Compensation, etc.

Sexual Orientation – Heterosexuality, homosexuality and bisexuality.

Domestic Abuse, Sexual Assault and Stalking Victims – Persons who have been or are victims of domestic abuse, sexual assault or stalking.

Local Fair Housing Ordinances Protected Classes

The City of Madison and Dane County have these additional protected classes:

Military Discharge Status – Type of military discharge, also including active duty status.

Physical Appearance – The outward appearance of any person.

Political Beliefs – A person's opinions concerning the social, economic and governmental structure of society and its institutions.

Student Status – Having or not having standing as an enrollee of a school or apprenticeship program.

Domestic Partnership – Two adults in a relationship of mutual support, who occupy the same dwelling as a single housekeeping unit, and whose relationship is of a permanent domestic character.

Tenant Union Association – Persons who form or are associated with a tenant union.

Gender Identity – Identifying or presenting oneself as male, female or androgynous, regardless of one's biological sex at birth.

Genetic Identity* – Genetic information unique to the individual, including information about genetic tests.

Citizenship Status* – The immigration status or citizenship of any person.

Section 8 Housing Vouchers – Participants in the Housing Choice Voucher Program.

Homelessness* – The status of lacking housing, including having a shelter or transitional housing facility as a primary residence.

Nonreligion* - Atheism, agnosticism, or other disbelief or lack of belief in the existence of God or gods.
