12.16.20 Governor Walz Announcements - Governor Walz announced changes to the Safe Learning Plan for the 2020-21 School Year on December 16, 2020. One of the major changes in the Safe Learning Plan states that starting on January 18, 2021, every elementary school across the state may choose to operate an in-person learning model as long as they are able to implement all updated health and safety measures.

PLEASE NOTE - On December 8, 2020, the East Grand Forks Board of Education approved transitioning students back to school for in-person instruction for grades PK-5 and hybrid model for grades.

transitioning students back to school for in-person instruction for grades PK-5 and hybrid model for grades 6-12 on Monday, January 4, 2021. Since the decision was made and communicated to families and staff members before the 12.16.20, the District does not need to follow the January 18, 2021 rollout process listed in the updated Safe Learning Plan for 2020-21. East Grand Forks ISD 595 is planning to have students return to school in the models listed above on January 4, 2021. If something happens that would not allow for the transition, families and staff members will be notified as soon as possible. MSHSL Winter Activities Update - Governor Walz also announced the extension of the pause to youth activities through January 4, 2021. There was hope that the pause would be lifted at the end of this week, but it did not happen. I am thankful that a date has been set and planning for the start of winter activities can begin.

COVID-19 Case Numbers - The most recent MN 14-Day Case Rate by County was released today and is continuing to drop. The latest 14-day number for Polk County of **165.55** is still very high, but it is nice to see the 14-day case rates drop.
