Ms. Flint discussed we are basically halfway through our school year in probably one of the hardest years for students and staff. She is very proud of everyone stepping up and working tirelessly to ensure all students (Face-To-Face and Virtual) are receiving excellent instruction. Mr. Shipman also stated how pleased he is with our students and staff working through the obstacles regarding COVID concerns.

Mr. Miles reported The Garland Company came by last week to inspect the roof. There is an area of concern on the NE corner of the High School portion along with some sealing issues that will be taken care of in January. We will also be looking at putting a ridge cap around the area of the Library/Science Room. Mr. Miles is looking at the upcoming 2021-2022 School Calendar. He is working with the teachers and will have one ready for approval in January. Mr. Miles mentioned that we currently have 3 students in quarantine. Those numbers have drastically decreased and we are pleased to have our students receiving face-to-face instruction. He stated the Mask Mandate has really helped and appreciates the support of the school board, parents, students, and community members. The main goal is to keep our students in school as studies have shown face-to-face instruction is much better than virtual.
