He stated that once kids are sent to school they are out of their control and that they expect the school to keep them safe.

changes at the JSHS and Parkview with lock downs; we now have a button to lock down (no one will be coming through the doors) and discussing what to do at the EEC building. When this event occurred our kids were safe, which was the primary focus. Once the police were called, which was quickly, it was then out of our hands. We went away with lessons learned and reflected on things we can improve on, and also if something does happen we are better prepared. We responded at 8:40 to send out a robocall to all parents, that didn't reach everyone, so is there a better way to do it (we will look into), but some numbers were disconnected, or the spouse received it instead. We will work on our communications and have a meeting scheduled with the town to reflect on getting better. He also shared about the Superintendent's Academic Awards night and how well it was attended in honoring specific academic awards.

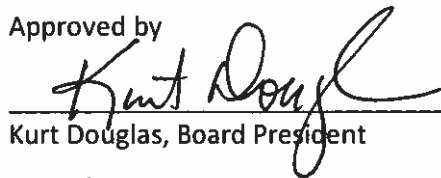
