## 1. Superintendent's Report

- a) Columbia REA Donation Superintendent Fry thanks Columbia REA for their donation to the district to support student learning during the pandemic.
- b) Comprehensive Sexual Health Education Roadmap Mr. Fry laid out the timelines regarding SEB 5395. College Place Public Schools will form a team and begin work in the Spring.
- c) Mode of Learning Update Full Remote Learning is continuing through winter break. The team will evaluate conditions the week of Dec 28 for a return date.
- d) College Place Schools will hold a second Food Drive to support the community. Donations will be picked up December 6<sup>th</sup> and distributed on December 10<sup>th</sup>.

### 2. Principals Report

- a) Principal Aguilar, reported on the high school successes and celebrations and instruction during remote learning; Community Partnership Growth with Walla Walla University; The continuation of the high school winter traditions: The Giving Tree, CP Lions Club Partnership for Coats and Toys Drive, Christmas Eve Luncheon curb side pick-up; and Parade of Lights driving tour, despite remote learning.
- b) Principal Kasenga, updated the Board on JSMS enrollment numbers and talked about his gratitude for a caring and collaborative staff and the support from the families. Sager honored Veterans by asking students to provide a sentence defining service. Mr. Kasenga shared some of the responses. He spoke about the interventions and extensions staff is providing and a distance learning playbook conversation with great results.
- c) Principal Ferraro described the hard work staff is doing with interventions to reach all students. They are working on ways to create ways for students to engage more in the afternoon. The goal for the 2<sup>nd</sup> trimester is to remove student's obstacles, improve on student attendance and engagement and work with families for a more successful trimester.
