Season's Greetings EGF ISD 595 Families and Staff Members!

The final day of school for calendar year 2020 is officially in the record books and I am looking forward to 2021! The last nine months have been very challenging for everyone and I greatly appreciate all of your efforts. You have risen to the challenge and we are starting to see some light at the end of the tunnel. There will continue to be some bumps in the road as we head into 2021, but things seem to be improving daily. Please continue to follow the safety recommendations and stay healthy! I am really excited to see students and staff members back in the buildings on Monday, January 4, 2021! The distance learning period served its purpose, but it is not the best learning model for a majority of our students. I hope that the case numbers will continue to decline and we will be able to transition all of our students into in-person instruction at some point in the near future. Please take a little time to review the following information and feel free to contact me if you have any questions or concerns.

Return to School on Monday, January 4, 2021 - The East Grand Forks ISD 595 Board of Education approved a plan to have students return to school for in-person instruction for grades PK-5 and hybrid learning for grades 6-12 on Monday, January 4, 2021. The District fully intends to continue with the approved plan and no changes are expected at this time.

• Activities Calendar Error - The 2020-21 EGF Activities Calendar states that there is no school January 4, 2021. Please disregard the error! The first day of school after the holiday break will be Monday, January 4, 2021.

School Board Meeting Information - The Board of Education tentatively scheduled a special school board meeting on Tuesday, December 29, 2020 to discuss the latest COVID information and return to school plans. Due to changes made to the Safe Learning Plan for the 2020-21 School Year by Governor Walz and the MN Department of Education, moving to another learning model is not allowed before January 18, 2021 unless a school district had approved a transition plan prior to December 16, 2020. EGF ISD 595 did approve a transition plan on December 8, 2020 and we need to stick with the plan. There is no need for a special school board meeting and the next scheduled regular meeting of the Board of Education will be on January 11, 2021.

The final regular school board meeting of the year was held on December 14, 2020 and Missy Thompson was recognized for her dedication and service to the students, families and community members of EGF ISD 595! Missy has done a wonderful job of serving on the school board since 2013 and we will miss her. Lynn Brott was elected to the school board this fall and her term will start in January. I would like to thank Missy and Lynn for their commitment to providing an expectation of EXCELLENCE for every learner, every day!

COVID Updates - The latest (12.17.20) 14-day case per 10,000 number for Polk County dropped to 165.55 (November 22 - December 5). Please go to K-12 Schools: 14-day COVID-19 Case Rate by County to view the data from across the state. Polk County case numbers have been dropping and we will need to continue to do our part to help reduce the spread of the Coronavirus and keep our community safe. The number of reported positive COVID cases for school district students and staff members grew slightly between December 16, 2020 and December 22, 2020. It is extremely important for families and staff members to continue reporting COVID related information to the school district. Thank you for the help!
