0568. Construction Update

Toby Morris also provided a financial update on the high school construction project. Both addressed the construction and pay requests they are presenting to the school board for their review and approval.

- 0572. <u>Curriculum/Academic Updates</u> Connie Kaltenbach, Director of Curriculum/Instruction/Assessment, provided an update on OLCSD digital learning for K-8 students. Stephanie Eisenmenger, High School Principal, also provided an update on how Lakota Tech High School staff are reaching out to students in an effort to assist them in achieving success in their coursework during this challenging time.

James Knutson, Lakota Tech High School Athletics Director, provided information in regard to recent parent meetings the high school has hosted digitally, and reported on the high interest received from students in regard to the winter activities being proposed and implemented. Mr. Knutson further reported that all high school coaches have been following the COVID-19 plan in regard to proper sanitizing and social distancing when students are together during sports conditioning, The high school is also maintaining groups of ten students or less when they are conditioning.
