Dear Coach and Athletic Director,

The Tri County Wrestling Dual Team Invite has been scheduled for Friday, January 8, 2021, beginning at 2:00 p.m. Reserve matches will be set up by coaches before varsity duals.

Spectators for the Wrestling Invite - We will do the following: Subject to change per NSAA guidelines

- Each school will receive 30 purchase permits to give to household members or grandparents of participants
- I have attached a sheet with 10, so you can make copies on your end. The 30 does not include wrestlers, coaches, administrators, or managers. The school will be responsible for distributing them to their fans
- Spectators must present the permit to purchase and pay at the door
- We do not need a list of names of those who received a purchase permit
- No ticket = no entry
- Masks are required and fans need to social distance as much as possible

Coaches' meeting: 1:15 PM in library

Weigh-ins: Scales open @ 12:00

Friday: 1:00 p.m. Weigh-Ins begin. Wrestling starts at 2:00 p.m.

Schedule/Seeding: This year's tournament will follow a dual meet format. Submit entries in Track Wrestling.

Teams will be seeded by their winning percentage when adding the record up for all the varsity competitors on their team. Their winning percentage will be deducted 4 percentage points for every weight class they do not fill out. This makes an attempt for the best duals to happen during the final rounds.

We will wrestle 5 rounds on Friday. JV matches will be wrestled after the varsity dual on the first open mat. We will be wrestling in both High School and Elementary gyms, teams may have to change gyms between rounds.

Mats: We will be using 4 mats with 2 mats in the High School Gymnasium and 2 mats in the Elementary Gymnasium.

Awards: 1st and 2nd place team trophy. Team plaque given to the team with most pins. Sixteen 1st place medals for every member of the winning team. Sixteen 2nd places individual medals for every member of the 2nd place team. The top individual in each weight class will also receive a medal.

We also have a belt for photo opportunities for the top of each weight class and top team. The team with the most team wins over the five year span will get the belt for their trophy case.

Participating schools: Auburn, Centura, Fillmore Central, Humboldt Table Rock Steinauer, Meridian, Republic County, Weeping Water

Entry fee: \$125.00 per school

Admission/Passes: Admission - Adults \$5.00 Students \$4.00.
Passes will not be honored.

Team Parking: We ask that you enter the drive through gate located on the Southwest corner of our school when arriving. Please enter the west gym doors to our school. School will be in session, so this will help alleviate confusion. Your busses will be allowed to park on the west side of our school.y.

Hospitality Room: Limited to Coaches, Administrators and adult meet help only. Meal count is due January 4, 2021 at 9:00 a.m.

WRESTLING

- **Capacity Limitations**
 - **Per the current statewide DHM, attendance at indoor extracurricular events will be limited to household members or grandparents of participants only.**
 - **Permit to purchase will be distributed by the school.**
 - **Those with purchase permits are still required to pay admission.**
 - **If you do not have a permit to purchase, you will not be admitted to the invite.**
 - **Spectators are required to sit in household groups maintaining 6 feet apart.**
 - **Bleachers are marked to encourage proper social distancing.**
 - **Tri County Schools reserves the right to change capacity and spectator limitations at any time.**
- **Masks are required for all spectators, game workers, coaches, and athletes not actively competing.**
 - **Officials and those actively participating are not required to wear masks.**
- **Home and away spectators will be seated in designated areas.**
- **Areas in the bleachers will be marked for each schools' spectators and athletes.**
- **NO STUDENT SECTIONS**
- **No children or students will be allowed in the hallways, classrooms, etc.**

- Spectators will not be allowed in the rows/area immediately behind and around the team benches.
- Limited concession stand menu.
- No cheerleaders allowed.
- No pep band.
- Visiting team is asked to screen athletes prior to departing for Tri County.
- Locker rooms
 - Shower facilities will be assigned upon arrival.
- Stay off the floor at the conclusion of the contest.
 - Spectators should clear the building immediately following the contest to limit groups from gathering. Spectators will leave the facility through their designated exits.
- Athletes and coaches should proceed to your designated area and/or exit the building as quickly as possible.
 - Please do not gather with your team in the gym at the conclusion of the competition. Leave the floor and building as soon as possible.
