Ms. Crotty - The Board of Education officially began its Superintendent Search with Dr. Mary Broderick of the CT Association of Boards of Education on October 6th, 2020. At that first meeting, we discussed search guidelines, the vacancy posting, and how we would develop the leadership profile. The Board of Education sought the insight of its school and community through a survey, interviews, and nine opportunities for stakeholders to take part in Zoom focus groups with our search consultant from October 13th through October 20th. In addition, twenty individuals, including parents, teachers, administrators, staff, and others reached out and spoke with Dr. Broderick directly, and 228 residents and staff participated in the survey. The information yielded insights on the community's desired qualities, skills, expertise, and characteristics they wanted in a new superintendent, and the strengths and challenges we face

in our district. The Search Committee used these results to develop its leadership profile which outlined, that collectively, our community stakeholders wanted someone who:

- · Communicates and collaborates effectively in schools and community
- Builds trusting relationships with students, staff, and community
- · Shares vision of excellence and innovative instruction
- · Accessible, approachable, and visible in schools and community
- · Keeps students' growth and wellbeing the primary focus,
- · Dedicated commitment to Watertown and it's vision and mission
- Decisive, confident, objective problem solver with good judgment and knowledgeable

The Watertown Board of Education took very seriously its responsibility to find the best possible candidate to lead our school and tonight, I am pleased to report that we believe we have found that person in Dr. Alison Villanueva- welcome, Dr. Villanueva, thank you for joining us this evening.

Dr. Villanueva rose to the top of the group of the excellent candidate pool, demonstrating a thorough understanding of educational excellence, communicating a collaborative, open, and relational leadership style, and relaying an impressive understanding of Watertown, our Vision of a Graduate and District Improvement plan. We believe Dr. Villanueva will help us move successfully through current pandemic challenges and help us to realize our district vision. She has a desire to be in a school district located in close proximity to her family and friends and wanted to be in a school district known for its tight knit community and hardworking administrative and faculty team.

Dr. Villaneuva most recently served in a central office level position as the District K-12 Humanities Supervisor in Ridgefield, CT where she was also nominated for the AASA Women in Leadership Award by faculty. Dr. Villanueva's professional career brings a variety of educational perspectives to the Watertown community. She began her career as a Music teacher and also served as a high school Humanities teacher, then an elementary teacher and acting principal, all in the Ontario area. After moving to New York City, Dr. Villanueva worked in New York City schools as a literacy specialist and coach. For five years beginning in 2010, she became codirector of Studies in Educational Innovation at Columbia University Teachers College, a world-renowned center dedicated to building K-12/ University partnerships with educational systems around the globe. Dr. Villanueva began her Connecticut work as a Principal in Danbury and in Ridgefield Public Schools before taking on her current leadership role. She is also an adjunct professor in the department of Educational Leadership at Sacred Heart University, where she specializes in advanced curriculum and educational law and finance.

Becoming a member of the Watertown community is very important to Dr. Villanueva. She said, "One of the most important things I am looking forward to is collaborating with the administrative team and local town constituents to listen and learn more about the Watertown community. Understanding the local 'way' of Watertown and learning about its history will be essential as I onboard".

Dr. Villanueva received her Honors Bachelor of Arts in English Literature from York University in Toronto. She earned her first Masters Degree in Literacy Education from New York University, and then a Master of Philosophy from Columbia University. She earned her Doctor of Philosophy in English Education from Teachers College, Columbia University as well.

Dr. Villaneuva is devoted to getting to know the heart of Watertown and its schools, and told the Watertown Search Committee, quote: "The opportunity to lead Watertown Public Schools is not only an honor and privilege, but where I aim to become part of the community for many years to come". Dr. Villanueva, thank you for being here with us this evening.
