She was a brave and honest participant in the high school's Anti-Defamation League workshop last year, and her insights about being an adolescent in 2020 made the workshop more meaningful for both staff members and all of the students who were in attendance. Kaytlynn was a recipient of a Watertown High School Good News Call recognition for being one of the first students to offer to help her teachers with tasks and for volunteering her time to make sure the school library ran smoothly. Most importantly, Kaytlynn cared deeply for her family and friends, often mentioning her mother and grandmother in conversation about how much they meant to her. Our school district's most sincere thoughts and condolences are with Kaytlynn's family at this very difficult time. I would ask you now to please observe with me a moment of silence.

F. Recognition & Award

Ms. Crotty – Dr. John Ramos has served as the Interim Superintendent for Watertown Public Schools since August 27th, 2020, and right from the start he quickly became an integral part of the community. Unfortunately, his time with us will come to a close as of tomorrow, December 15th. While Covid-19 has ended his time with us just a little earlier than anticipated, as you can see, Dr. Ramos is doing well. We are grateful for his service to Watertown Public Schools at such a critical and transitional time in our district. Dr. Ramos took the reins when we needed him most and immediately provided a stabilizing force during extraordinary circumstances. Given the pandemic and its impact on our community, Dr. Ramos had to make critical decisions from day one, and he did so with integrity and thoughtful expertise. He immediately focused on partnering with our leadership team to provide comprehensive guidance on the re-opening of

our schools. His dedication to our students, staff and families was nothing short of incredible, and he did not allow anything to compromise the safety and wellbeing of our community. G. Report form Student Council Representative – Natalie Lindstrom

Ms. Lindstrom - At **Polk**, as hard as it may seem to believe, Last week Polk school closed out their first trimester of the school year and shared students' first trimester report cards with families. While we know it hasn't always been easy, distance learning seems to be going well overall. Polk is pleased to be offering more live instruction and support for students in this learning model and love getting to see their kids every day! They are so grateful for all of the help, support, and kind words families are offering to their children and to us! In conjunction with John Trumbull and Judson, Polk Staff will hold a reverse parade on Friday, December 18th from 2-3. We're excited to welcome our families to come say hello and wish everyone a happy holiday before we close for winter break.

At **Judson**, Mrs. Raymond is incredibly proud of Judson staff members, students, and families as we transitioned to Remote Learning. At this time last year, this concept of "remote learning" would have been inconceivable! While this is so frustrating for many of us, it really is such a feat that we are meeting head on...together. Mrs. Raymond began live meetings with each grade level for daily morning announcements. It has been such a pleasure to see all the students. Report cards for our first trimester were made available on Monday, December 7. Our Student Council is hosting a Spirit Week which began today and will end on Friday, December 18 with a different theme each day. Spirit Week will conclude with a parade at Judson School. We are hoping our families will take a moment to come say hello to the faculty and staff of Judson School from 2:00 pm until 3:00 pm. In lieu of the annual Giving Tree, our staff members have purchased gift cards to donate to Watertown's Social Services for our families who are in need this year.

At **Swift**, the Swift Unified Sports team recently found a safe way to get together and participate in an after-school activity at school. On November 17th, members of the Unified program including a mix of general ed and special ed students had a great time playing "indoor bocce" in the gymnasium. For some it was their first time playing this backyard game. This was part of the Sports Challenges set up by the CIAC and Unified Sports due to the cancellation of fall tournaments. We are hoping to hold two more Unified challenges this winter once we return to in-person learning.

At Swift we value our relationship with our local veterans and we have traditionally participated each year in the annual Pearl Harbor Remembrance ceremony held at the Oakville Green. This year, students remembered this significant day in American history in a different way. Students viewed a number of archival videos of the events of December 7, 1941 and watched short documentary interviews with survivors and eyewitnesses of the tragic events of that "Day Which Will Live in Infamy". Discussions followed in each class about the reason's nations "go to war" as part of our curriculum unit on the causes of the American Revolution.

And at Watertown High School, the Watertown High School Science department has been developing innovative ways to continue students' experiences with laboratory activities. A team of students had been videotaping the laboratory procedures, another student wrote the script of the lab activity, and another student edited the video so that it was clear and easy to understand. The department hopes to create a video library of lab activities for use in future years as well. On Tuesday, December 8, Watertown High School teachers participated in a professional learning activity about individual conferencing with students across the content areas. Individual conferencing allows teachers to provide specific instruction to students, and it encourages students to articulate the steps they used to complete a task, as well as explain their successes and areas of struggle. The purpose of Tuesday's professional learning was to get teachers to practice our conferencing protocol with each other using an object they created with Play-Doh. This activity allowed teachers to have a bit of fun while they became accustomed to the conferencing template, playing the roles of student and teacher in their practice. Teachers have a minimum number of individual conferences with students to complete in the upcoming weeks.

Ms. Crotty - As we know, an interim superintendent is necessary to maintain all district functions in a proper and seamless manner, and Dr. Ramos and I are pleased to recommend this evening that the Board of Education appoint Watertown High School Principal, Dr. Janet Parlato, to fill the role of Interim Superintendent, effective Tuesday, December 15, 2020. Prior to her appointment as Watertown High School Principal in July 2019, Dr. Parlato was our Assistant Superintendent and Director of Curriculum &Instruction since August 2013, and she also served as interim superintendent for seven weeks in 2018. Before coming to Watertown, Dr. Parlato spent twenty years in the Berlin Public Schools as both a teacher and a building administrator.

Dr. Parlato's breadth of administrative experience will aid in her ability to simultaneously continue in her position as the High School Principal and will provide us with an effective, seamless transition from December 15th until a new Superintendent begins. Ms. Crotty - I am happy to report that the Superintendent Search Committee has concluded its work and has selected a new superintendent of schools. I anticipate that the Board will be able to vote on and name the new Superintendent at a Special Remote Meeting of the Board of Education on Monday December 21st, 2020 at 6:30 p.m. I would like to thank Lisa Fekete, our Director of Curriculum and Instruction, Mary Lou Lerz, Administrators Union President & Swift Middle School Principal, and Terry Baldwin, Watertown Educators Association President and Swift Middle School Teacher, for accepting the Board's invitation to join us on the search committee and working side by side with us throughout the process. There is no question that they went above and beyond for their district in this endeavor, balancing the incredible workload they currently carry, on top of dedicating themselves to the superintendent hiring process over the last two months. On behalf of the Board, I thank you for that.
