

**EDUCATION HALL OF FAME AWARD
NOMINATION REQUIREMENTS**

The purpose of the Education Hall of Fame Award is to recognize outstanding and extraordinary contributions to the Fayette County School Corporation by former teachers and administrators. The Fayette County School Corporation invites employees, parents, and community members to nominate candidates for this prestigious award. All nominations will be reviewed by a five person selection committee composed of a Board member, a parent, a certified teacher, a patron, and the superintendent once nominated.

CRITERIA FOR NOMINATION

- I. Any certified teacher or administrator may be nominated.
- II. A minimum of fifteen (15) years of service, five (5) years of which must have been in the Fayette County School Corporation.
- III. The recipient must have made a noteworthy and extraordinary employment contribution to the Fayette County School Corporation which merits recognition for excellence.
- IV. Candidates must either be deceased or have been retired one or more years at the time of induction.
