BISHOP GORMAN CATHOLIC SCHOOL TUITION REDUCTION INCENTIVE PROGRAM (TRIP)

Many of our new families hear about Bishop Gorman Catholic School through a personal referral from our existing Bishop Gorman families. You are our best form of advertising, and we want to reward you for promoting our school to the community. Through our Tuition Reduction Incentive Program (TRIP), the parents and guardians of current Bishop Gorman students have the opportunity to receive a significant tuition reduction for the 2023-2024 school year.

REQUIREMENTS FOR TUITION REDUCTION

- For each new student referred to attend Bishop Gorman for the 2023-2024 school year, the current Bishop Gorman family responsible for referring the new student will receive a \$1000 credit on their tuition for the 2023-2024 school year. The \$1000 tuition credit is for each new student referred to Bishop Gorman. For example: If three new students are recruited to attend in 2023-2024, the family responsible for the referral will receive a \$3000 reduction on their tuition for 2023-2024.
- Credit will be applied to tuition only. Fees, etc. (where applicable) must be paid.
- The family of the newly referred students will be required to sign an affidavit identifying the sponsoring Bishop Gorman family responsible for their referral in order to identify the family eligible to receive the tuition credit. Only one family can be designated as the referral family.
- Tuition credits cannot be transferred from one family to another. Families have the option of donating their tuition credit toward the school's tuition assistance program. Donation letters will be provided for tax purposes.
- Tuition credits cannot be carried over from one year to the next.
- There will be no residual credit applied above and beyond the amount due for the 2023-2024 school year.
- The actual cash value of the tuition credit is zero dollars. Any benefits from the program are in the form of tuition credits for Bishop Gorman.
- Credits will be pro-rated depending on when the new student enrolls in school. If the new student does not enroll until the second semester, the tuition credit will be reduced in half to \$500.
- Any credit from TRIP that is given to a current Bishop Gorman family using financial aid will be taken from the family's out-of-pocket costs and not their financial aid.
- TRIP is only being offered for new Bishop Gorman students who are entering **grades 6-11** for the 2023-2024 school year. Students who attended fifth grade at St. Gregory Cathedral School in 2022-2023 are not eligible for the program.
- New Bishop Gorman students who previously attended the school must have been out of the school for one year before they are eligible for the program.
- The new student cannot have any siblings currently enrolled at Bishop Gorman.

The TRIP Program is subject to review and modification at any time. Interpretation of the program parameters will be at the discretion of the Principal.
