CALL TO ORDER:

Board Members in attendance were Edward Amberger, Timothy Tuttle, Greg Lewis and Douglas Norman. Gerald Gauck was absent. Also attending was Superintendent Jane Rogers. The meeting was called to order at 7:04 PM by Board President Edward Amberger. The meeting opened with the Pledge of Allegiance.

PUBLIC COMMENTS AND RECOGNITIONS

- Jesse Baugh, the new Ag Teacher and FFA Sponsor at Milan High School was in attendance and provided board members with insight on a recent conference he attended as well as things going on with the FFA program.
