Attending were Board members Gregory Lewis, Gerald Gauck, Edward Amberger, Timothy Tuttle and Douglas Norman. The meeting was opened by President Gregory Lewis.

Mr. Lewis stated the purpose of the hearing was to hear and discuss objections to and support of the proposed superintendent contract. Notice of the hearing was posted in the local papers and corporation website as according to state protocol 10 days prior to the hearing. Details of the contract were also posted on the corporation website as required. The details of the proposed contract of employment include the following: a three year term beginning on July 1, 2023, a base salary of \$118,000 and fringe benefits including insurance and retirement contributions.

At this time Mr. Lewis opened the hearing to the public for any comments in support of or opposition to the proposed contract. No patrons chose to comment.

With no further comments or discussion Mr. Lewis adjourned the meeting. Meeting adjourned at 7:01 P.M.

## A. SUPERINTENDENT COMMENTS

- Milan Elementary School has been accepted into the Indiana Literacy Cadre for the next two years. The Indiana Literacy Cadre offers a commitment from the Indiana Department of Education to help advance teachers' awareness and understanding of the evidence-based research on reading, reading development, and reading instruction specifically aligned to the science of reading. This is a two year program. In the first year, the state pays % of the salary for a literacy coach, while the school pays 1/3, then in the second year, the percentages are reversed.
- The application to the state to conduct summer school this summer has been submitted. We plan to offer courses similar to last year. There will be a REACH summer camp which will offer reading, math, STEM and other trips and activities. At the high school level, there will be credit recovery and possible agricultural experiences.
