#### MPA Updates /Winter Sports Guidance

The Maine Principals' Association announced that team-based practices and team-based scrimmaging for moderate and high-risk interscholastic winter sports, which were originally slated to begin on December 14, 2020, have been delayed until January 4, 2021.

The decision, which was made in collaboration with the Maine School Boards Association, the Maine School Superintendents Association, the Maine Interscholastic Athletic Administrators Association and the Mills Administration, comes as Maine continues to see an increase in COVID-19 cases, hospitalizations, and positivity rate.

The decision, however, allows skill-building or conditioning drills to begin as scheduled on December 7, 2020 with face coverings, physical distancing, no close contact, and in limited numbers when possible. This measure aims to allow student athletes the opportunity to participate in school sports to a limited extent despite the delay in team-based practice and within-team competition.

The State of Maine has also aligned its Guidance for Community Sports Activities to align with these changes.

#### Notes:

All winter coaches, paid and volunteer, must complete the free Covid-19 course called <u>Covid-19 for Coaches and Administrators</u> currently available on the NFHS Learn platform at <a href="https://nfhslearn.com/">https://nfhslearn.com/</a>.

Participants in school sports – All athletes, coaches, officials, staff – must wear face coverings during practices and competition, in line with Governor Mills' latest Executive Order. The only exception will be to hydrate.

Currently practice will begin on December 7th for conditioning and skill work only.

The regular season will start on January 11th and end on January 27th. We will not be permitted to play more than 2 games in a week.

There will be no spectators at any game's.

Sideline Cheering at games will not be permitted in 20/21. However, cheerleaders can still practice their routines for competition purposes.

Basketball will have a 12 game regular season with a chance of Statewide playoffs depending on the status of the State in the spring.

Currently we are not sure when the Middle School season will start or end but the Aroostook Athletic Directors are looking for the middle school basketball season to start in the late winter and early spring. (Facility issues across the region and also a shortage of officials)

Should a county be designated yellow or red, there should be no practices or games held until which time they are designated green.

Schools must follow the Maine CDC recommendations for reporting when a person involved in school sports is confirmed positive for COVID-19 or a close contact of such a person (see the Standard Operating Procedure for Investigation of COVID-19 in Pre-K-12 Schools in Maine that is posted on the Department of Education website).

The decision to sponsor a school activity is made at the local level. The MPA does not require approval from a school's local governing board.

There will be a period of time between each practice session for cleaning of facilities and equipment prior to the next group coming in. We will keep students in the same cohorts and not allow team members from another cohort to be in the gymnasium during another cohort's practice session.
