Superintendent's Report – The Superintendent presented a written report updating the Board on COVID-19. The District seems to have rebounded from the spike in cases that led to the high school moving to remote learning, but there are major concerns about staff members and the number of available substitutes. There is talk among superintendents about the prospect of a statewide school closure being inevitable with the numbers (cases, hospitalizations, ICU, ventilators) increasing every day. Our Safety Plan Meeting/Drill meeting was held on 10/13 to educate the new police chief about the history of our safety plan. We are continuing to work on internal communication systems in the event of an incident. The MS/HS roof project is complete and there was no overage in the final cost of the project. The addition of Nate Miller to our maintenance staff has helped get the locker room project moving forward again. The new lockers are installed now. Mr. Berry has been contacted by a current student and a former student who is working with an outside group about strategies to assess and address racial and ethnic diversity and inclusivity within our curriculum.
