The total amount to be levied is \$6,816,014 which is a \$6.05 decrease over 2019.

elementary going from 8-12. Calendar B proposal is in session 5 days a week with elementary going from 8-12. Dr. Chatterton would like to give the parents plenty of time to plan for the changes in schedules.

Code of Ethics #12: I will strive to keep my board focused on its primary work of clarifying the district purpose, direction and goals, and monitoring district performance.

Committee Reports:

Curriculum – the committee met on November 16th and December 10th. Hybrid learning and how that would impact the elementary schedules was a main topic. The survey that went out to parents, staff and students was also reviewed. There was a lot of data that still needs to be reviewed.

Delegate – the results of the Delegate Assembly voting was shared, including e-learning on election day, gun storage and if that should be pursued at the state level to encourage proper storage in the home, and teacher shortage.

Labor Management - Organizational Health Index (OHI) is behind schedule, hybrid (four step implementation)

Building & Grounds – Snow removal was discussed. Pre-school and BF classrooms will need new carpet – in bad shape. A schedule was set for that replacement.

Policy – submitted policies for first reading.

Transportation – reviewed the possibility of reducing the fleet by two buses.

SEAPCO hiring survey will be submitted in January for action. There are no changes anticipated from this year.

IDPH – new guidelines have been released. Most significant is that quarantine can end after day 10 if there has been no symptoms and after day 7 if a negative test is received to return on day 8.

There was no closed session.
