Solicitation Questions and District Responses are detailed below:

1. Question: We do not perform or offer any installation. Would the bid still be accepted.

District Response: Yes the bid will still be accepted.

2. Question: The quote asks for a cost for installation, indicating that we would be responsible for hiring and managing an installation company, which is not something we typically do or manage. Is that, to the best of your knowledge, an integral part of the quote? Or, can it be left as n/a?

3. Question: Do you have a diagram of the room that includes the desired location of each piece of equipment?
