Solicitation Questions and District Responses are detailed below:

1. Question: Queries asked related to the RFP and their respective responses

District Response: The District responds to all solicitation questions in a question-and-answer format called an Amendment. The Amendment can be found on the District's website to cross-reference.

2. Question: Estimated budget allocated to this RFP

District Response: The budget allocated will be discussed with the successful bidder.

3. Question: Whether companies from Outside USA can apply for this? (like, from India or Canada)
