# 7.0 REPORTS AND PRESENTATIONS

- 7.1 ASB President Report Tylar Banta Due to the restrictions of COVID-14 on the community, ASB has been extremely creative with all their endeavors this year by utilizing social media platforms, BUHS' online site, emails, etc. ASB is pleased to report that they are going to be partnered-up with BUHS' Link Crew in hosting virtual events starting next semester. Virtual events are in the works at this time and they hope to have more information at our January Board Meeting. Right now, BUHS is gearing up for finals; ASB has given them an option between two assignments. The first option is a written assignment with the prompt: Do you think that high school dances are positive high school traditions or negative ones? Defend your opinion. The second option is a multimedia presentation with the prompt: Convince someone why social media is so important to modern society. Use Reasons to convince your audience to see your viewpoint.
- 7.2 BUHS Student Senate Report Sierra Burror, Secretary Sierra opened up by reading the Senates' Mission Statement. This week they are focusing on stress relief for students and staff. In their December check-in, they are emphasizing wellness and providing resources for finals week and the holiday break. Last Wednesday they held their monthly open panel meeting where they discussed the results from their last check-in. Those results were used to moved forward with research for the school=side mental health initiative. Students also showed interest in mental health resources and other stress relief services. In the next few months, the Student Senate would like to focus on setting up a webpage on the school website with resources and information. They also plan to have an official logo in January 2021.
- 7.3 Administration Reports Single Plan for Student Achievement (SPSA) (enclosures)
  - 7.3.1 Dr. Gretchen Skrotzki/Garrett Carr, Bishop Elementary School much has remained the same, same goals as last year. Some strategies have been adjusted due to the pandemic. Goal 1 PLC leader team just finished AVID, on good track to obtain this goal in June. Goal 2, keeping it as a goal, but we will see how it goes. Goal 3, partner talks even at social distancing, on track to obtain that goal. Goal 4 quite a few things to connect w/students last year, but more difficult this year, but we are still

trying. Counselor is not meeting with students 1/1, but she is zooming in. Kathy wants to say thank you for the nicely done report, although she feels Dr. Skrotzki is being somewhat harsh on herself, the map scores did not change, but what Dr. Skrotzki did not point out, huge change in math students below standard are up. Dr. Claudia Moya-Tanner thanked Dr. Skrotzki very much.

- 7.3.2 Derek Moisant/Danielle Grate, Home Street Middle School Goal 1, 90% of HSMS Students will have a GPA 2.0 or above by June 2021. Goal 2, with COVID restrictions most conferences have been moved to virtual platform. HSMS and the I.T. Team has worked very hard to make sure students are outfitted with Chromebooks and internet hotspots (100% internet access to all students) Goal 3, 50% student efficient in Math & ELA by June 2021. Getting students to 50% is a lofty goal, especially since their 2019 SBAC they were in the low 30% range. Goal 4- 75% of HSMS students feel safe & connected at school. This goal addresses school wide safety and connectedness. Being able to be in seat, to get most instruction to give them, is part of this goal, school counselor, Linda does a great job, she meets in person/virtually, and is really helpful for the students. Another part of this goal, attendance, it has been the worst year for attendance, we have not hit 90% this year. Danielle has a great plan, raffle program at school based on good attendance and work completion. Each week, teachers will review students' work and enter them into the raffle. Several local business have donated several items, for example: beanies, helmets, yeti, and gift certificates. The prizes will be displayed in the main hall. They will post the winners on Instagram each week. HSMS currently has 19 discipline instances this year, which in a traditional year is usually 19 in a week. Dr. Claudia Moya-Tanner really appreciates the purpose and detail.
- 7.3.3 Dave Kalk/Jordan Rose, Bishop Union High School Dave identified goals to continue to move forward. Goal 1, to have 85% of graduating seniors completed the A-G requirements or a CTE Pathway that allows for eligibility for military, journeyman employment, or advanced placement in postsecondary institutions. BUHS is providing Tier 2 support for students who are performing below required level (C or better) while meeting A-G requirements. Goal 2, for the 20/21 school year specifically, teachers will collaborate within departments to identify the essential standards that will need to be covered by the end of the school year in order to address the transitions to subsequent courses that will follow. BUHS will continue to provide AVID, use materials that are aligned to California Common Core Standards, EDI strategies in the classroom, and provide teachers and students with appropriate and adequate technology to deliver and receive online instructions during DL. Discussions regarding the purchase and use of swivel cameras or Owl have taken. Goal 3 - Due to the closure of schools for in-person instructions, state required "Hold Harmless" guidelines, and cancellation of statewide testing, no data is available to measure academic growth outlined in this goal. We have added 2 strategies this year. Target intervention, small groups after school, and on Friday's we have been offering Boot camp. Offering 4 days a week for high at risk students. Biggest impact is getting them on campus; students are doing best when they are on campus. Goal 4, is to reduce the suspension rate by 5% as of June 30, 2021. This goal will remain the focus for BUHS for the coming years but for 20/21 school year that focus will shift to social-emotional well-being of students who are struggling with the impacts of school closure, limited in-seat instruction, lack of access to extracurricular activities (athletics, clubs, etc.), and home environments. We have been using Northstar counseling on campus quite a bit. The districts' Suicide training was a great training and glad to have it this year. He is concerned about the students, for example; our seniors, second year without sports, it is truly impacting them. All the Board members thanked Dave.

7.3.4 Patrick Twomey, Alternative Education, (Palisade Glacier High School,

Keith Bright and Bishop Independent Study) — Mr. Twomey feels this has been a great year to shift over to Alternative Education, with the WASC process; it has helped with his SPSA as well. Goal 1, All students graduate before their 19th birthday, 2 staff stay current with teaching practices, teacher visits, credit earning rates, 75% or better earn credits. Goal 3, relationships, respect self, others, and the environment. Most of changes took place in this goal, narrow actions down to make obtainable. Very well in line with WASC and LCAP. Kathy Zack asked how school attendance rate is going right now. Mr. Twomey feels it is poor, alternative education historically has been poor, this year it has even taken down turn from previous year. Some Distance Learning students earn credit slower than in seat. Nevertheless, even in seat is lower than previous year. Dr. Claudia Moya-Tanner thanked Mr. Twomey.

Dr. Claudia Moya-Tanner thanked the Principals for their reports; we (the Board) know how hard it has been. The goals remain even though we do not know what is going to happen one day to another. We are very aware of your tremendous effort, parents, staff, and students. Everyone is working hard and we see it. Last month discussed assessments, you seem disappointed, you are used to setting standards, but everything we have been doing is different since March. Even though assessments are different the effort is tremendous and your willingness to do things different. You are teaching students a valuable lesson, you are showing up for them that is very important, they see you and see you care and setting a great role model to our students. So thank you that is very important.

#### 7.4 Katie Kolker, BUSD Superintendent

7.4.1 COVID and Blended Learning Update - We are in the red tier; we are among the few school districts that are in the red tier. We are currently one week into stay at home order, two more weeks of the order and then we will be re-assessed. California Public Schools that were open prior to the Stay at Home Order may remain open. Game changer, as of 5 pm today, Public Health reported 44 new cases over the weekend. No students or staff have been hospitalize to date due to COVID-19. Mostly asymptomatic in our cases. Superintendent Kolker shared with the board to expect to continue having "rolling" class closures throughout the winter due to quarantines/contact tracing closures. We are currently quarantining for 14 days from date of exposure, per CDPH, but CDC has recommended 7-10 days so we expect this guidance to shift soon, her hope is this is reality soon, just has not yet. January will all depend on number of cases in our county, so she will be in contact with Public Health.

7.4.2 Grading and Assessing Academic Progress During the Pandemic – Locally and worldwide, students are struggling to engage in learning and maintain passing grades. BUSD is continuing to offer help to our students. Grades are going to be given, but it is going to be looking different this year. There are far more F's this year than other years. We have and will continue to offer support for our students with intervention after school at all sites, and have flexibility in when/how students submit their homework. We are also providing targeted support prior to assessing for Tier III qualification. There are multiple measures in place (few examples), formative, screening and grades reflective of knowledge and skills to the degree material was able to be taught/learned. Katie feels our community has been resilient because families and staff are working so hard.
