Currently every other classroom has an access point. We need to expand, putting access points in every classroom and adding access points to larger rooms like gyms and cafeterias. Currently we have eight exterior access points around the outside of building. Expanding coverage on exterior of school building by adding more to building and putting access points at the feature field. Update all existing access points from 802.11n to 802.11ac. More access points in turn will need larger server (WAC).

We will be using our Federal E-Rate funds in conjunction with SSIP funds to purchase access points and switches for this project.
