1. CALL TO ORDER:

The Board of Education of Community Unit School District #3, Fulton County, met in regular session on December 16, 2020, in the Cuba Elementary Library, 652 East Main Street, Cuba. President Sue McCance called the meeting to order at 6:30 P.M.
