Special Meeting

1. The special meeting was called to order at 12:15 p.m. by President, Monty Breneman.
2. Motion by David Bell, seconded by Rhonda Wright, to adopt the agenda for the special meeting. Aye-5 No-0
3. Kathy Robertson, Superintendent, led discussion on Lincoln High School hosting and participating in the NPL Tournament this week. The district has a policy regarding no activities or sporting events on Wednesday night as this evening is set aside for families and church activities. Due to extreme weather this past weekend and the large number of schools being involved in the NPL Tournament, tournament play was postponed for this evening with games resuming on Wednesday, games will continue on Friday, and tournament play ending on Saturday. It was noted that the board will not make a practice of scheduling activities on Wednesday, but due to the unforeseen weather conditions and the number of schools involved, this was beyond control of the board.
4. Early release dates and times during the NPL Tournament were voted on at the Board of Education meeting on January 3, 2017. Due to postponing games and changing nights, those early release dates and times need to be amended at this meeting. It was noted that all consolation games will be played at Sylvan-Lucas Unified, not in Tescott as was published earlier.
