- 1. The Special Meeting was called to order at 6:00 p.m. by the President, Monty Breneman.
- 2. Motion by Rhonda Wright, seconded by Debora Zachgo, to adopt the agenda. Aye-6 No-0

6:01 p.m. Jared Spear arrived.

- 3. Monty Breneman thanked Kathy Robertson for the blue polo shirts that she had personally purchased from PawPrints class at the Lincoln Jr/Sr. High School for each board member. They were waiting at each board members respective place at the board table this evening. Mr. Breneman encouraged board members to wear their shirts for board member pictures next month.
- 4. Monty Breneman stated that the Board of Education has received a letter of interest from Jeana Eckhart to fill the vacancy on USD #298 Board of Education, created when Chad Walter resigned his position. Mrs. Eckhart was present at the meeting and invited to join board members at the board table to state her reasons for pursuing this endeavor. She thanked board members for considering her for this position. She stated that she was born and raised in Lincoln County, had sons that attended and graduated from Lincoln Schools, she served on site councils as her children were going through the school system and had volunteered for many activities over the years. She noted the conflict there seems to be in the county at the present time and would like to be a part of the solution. Board members had no additional questions for Jeana, so Mr. Breneman thanked her for coming.

- 5. Kathy Robertson distributed an excel spreadsheet outlining the latest state budget plan with the proposed additional amounts for all districts. She pointed out while this is encouraging, legislators have recessed for three weeks and have no school funding plan in place. And on a larger note, the state has no way to finance any additional funds proposed for districts, due to the lack of a tax plan for FY-18. In the most current efficiency report, they are suggesting freezing KPERS, cutting highway funds, shifting PAT funding back to the federal level as opposed to the recent shift to the state level, and changes with the Tobacco monies. In order to close out the FY-17 fiscal year, the state is recommending borrowing enough to end the year with \$50 million in reserves. The legislature has hired an attorney. Governor Brownback vetoed the latest tax bill and at the present time, nothing further has left committee.
- 6. Under Bond Discussion, Monty Breneman started the dialogue by stating that everyone is aware that the bond has failed; however, the fact remains that district needs have been identified, still remain and loom bigger every day. Kathy Robertson said that she had contacted the State Department of Education about the availability of QZAB funds after the results of the bond issue were reported to the board office. Craig Neuenswander notified the district that USD #298 Lincoln has been approved for this request. Stipulations require that these funds be paid back within ten years and Mrs. Robertson is in the process of securing local bank involvement, if the board chooses this path of funding. Mr. Breneman asked that board members give thought to ranking projects and funding and this item will be on the agenda for the May meeting.
- 7. Kathy Robertson reported that she had attended the County Commissioner meeting at the Lincoln County Courthouse on Monday at 10:30 a.m. for discussion of ENEL distribution. Since it has been suggested that the funds be distributed to finance district projects up front, Mrs. Robertson was present to inquire. Dawn Harlow, County Clerk, informed those in attendance that these dollars had to be distributed annually to comply with cash basis laws. This would not and could not be an option. If ENEL would protest their property taxes, and taxes were abated, those monies would have to be recouped.
