**A RESOLUTION OF THE BOARD OF SCHOOL DIRECTORS OF THE SALISBURY TOWNSHIP SCHOOL DISTRICT ESTABLISHING THE COMPENSATION FOR THE ELECTED QUALIFIED TAX COLLECTORS FOR THE NEXT FOUR-YEAR TERM OF OFFICE COMMENCING JANUARY 2022 THROUGH 2025**

**WHEREAS**, Section 35 of the General Assembly Act of May 25, 1945, P.L. 1050, as amended (72 P.S. § 5511.35), provides school districts the power to fix the compensation or salary of an elected Tax Collector for the tax revenues collected for the said district; and

**WHEREAS**, Section 36(a) of said Act of May 25, 1945, P.L. 1050, as amended (72 P.S. §5511.36(a)), permits school districts the power to adjust the compensation payable to an elected Tax Collector by a resolution adopted prior to the fifteenth day of February of the year of a municipal election, effective commencing in the following term of the Tax Collector; and

**WHEREAS**, 2021 is a year of municipal election, and the Salisbury Township School Board of Directors (“the School District”) desires to adopt a resolution fixing the compensation for the four year term of the next elected Tax Collectors.

**NOW, THEREFORE, BE IT RESOLVED**, by the Salisbury Township School District as follows:

1. The Compensation of the elected, qualified Tax Collector, commencing January 1, 2022, shall be Twenty Five Thousand, Five Hundred Twenty Two Dollars and Fifty Cents (\$25,522.50) per year.
2. Any elected, qualified tax collector who claims compensation pursuant to this resolution must conform with the requirements as more fully set forth in the Local Tax Collection Law, 72 P.S. §5511.1 et seq.
3. The Tax Collector shall not be entitled to any other compensation, or reimbursement, unless otherwise required by law.
4. The provisions of this Resolution shall be severable, and if any of the provisions hereof shall be found to be invalid or unenforceable, the remaining provisions shall remain in effect.
5. Any resolution conflicting or inconsistent with any of the provisions in this Resolution is hereby repealed, but only insofar as such conflict or inconsistency.
6. This Resolution is adopted pursuant to the Local Tax Collection Law, 72 P.S. §5511.35(3) and 5511.36(a), as amended, and the Public School Code of 1949, as amended.
