# 1. Update on Various Buildings & Grounds Projects

- Director of Buildings & Grounds, Tyler Garrison, provided updates on current and upcoming projects of a larger scale that will be completed during the remainder of 2023 and into 2024. The list totaled twenty-seven projects and included the entrances to the FJSHS gymnasium and athletic fields, outdoor learning spaces and FES, and boiler system upgrades at both buildings.
- The committee approved moving forward with replacement of classroom flooring in one classroom at FES. The room currently has carpet and will be replaced with similar flooring to the FES commons area. This project will take place summer of 2023.

# 2. Compensation for Hours Dedicated to FES Boiler System

- Compensation for two members of the maintenance team was discussed related to their added workload expectations over the Christmas holiday, working in a twenty-four hour on-call status for consecutive weeks, and additional responsibilities assigned.
- The committee approved moving forward with granting additional time off and a one-time stipend for additional services as performed.

#### 3. Vendor for Student Photos

## 4. FY '23 Revised Budget

reported revenues and expenditures are accounted for as the first budget revision is
being finalized. A finalized revision is expected in the coming weeks.

# 5. Environmental Sensors Update & Planning

 Fairmont Jr.-Sr. High School Dean of Students, Andy Walden, presented information regarding the potential for installation of environmental sensors in the restrooms and locker room at FJSHS. The sensors would detect any vapors, smoke, carbon monoxide, and loud noises. A drafted plan was presented by Mr. Walden and discussion was held on this topic. The consideration of purchasing the sensor system was tabled for further discussion at a later date.

## 6. ESSER III Project Allocations

 Superintendent Traetow provided a brief update on the status of upcoming projects funded by ESSER III funds. Projects that have been added include classroom carpet replacement and outdoor learning spaces at FES, and a commons divider replacement at FJSHS.
