MINUTES OF SCHOOL BOARD MEETING March 14, 2023

A regular meeting of the Fairmont Area Schools Board of Education was held on Tuesday, March 14, 2023 at 5:00 p.m. in the City Hall Chambers. Members in attendance were Nicole Green, Mike Edman, Mari Myren, Julie Laue, Dan Brookens, and Jen Harris. Student school board member Solveig Senf was also present.

A motion was offered by Mari Myren, seconded by Julie Laue and carried to unanimously approve the February 14, 2023 school board meeting minutes.

A motion was offered by Dan Brookens, seconded by Mari Myren and carried to unanimously approve the March 14, 2023 school board meeting agenda.

Melinda Stewart, Spanish teacher, spoke about the Teacher of the Year process. Melinda was selected by her peers as Fairmont's Teacher of Year in the fall, having been nominated by Miles Duffey. That nomination was extra special since Miles was a former student turned colleague. Melinda has been touched and overwhelmed by the continued outpouring of support she has received from staff, students, parents and community members.
