THE SCHOOL BOARD OF BELLE FOURCHE SCHOOL DISTRICT NO. 9-1 MET IN SPECIAL SESSION ON MONDAY, JANUARY 25, 2021, AT THE BELLE FOURCHE MIDDLE SCHOOL LUNCHROOM with president Clem presiding and members Gilbert, Helmer (via conference call), Justice, Knapp, Reder and Tyndall present. Unless otherwise noted, all Board action was by unanimous decision.

President Clem called the meeting to order at 5:15 p.m.

Clem led everyone in the Pledge of Allegiance.

Motion Justice, second Gilbert to approve the agenda as presented. Motion carried.

Lunchtime Solutions, Inc. (LSI) provided a sampling of the school lunch menu for the School Board and administrators. Justin Olson, Food Service Director of LSI informed the Board about the District's success in offering free meals to children during the pandemic.

Surplus Property Bids
