A. K-2 Elementary Principal's Report: Mrs. Kathy Kulp:

- Mrs. Kulp stated that the kindergarten achievement in math and reading NWEA was very positive. Together
 the class scored 7 points above the national average in math and 3 points above the national average in
 reading.
- Mrs. Kulp stated that in first grade 51% of our students met or exceeded their goals on the math assessment, and 58% of students met or exceeded their goals in reading. The class missed the national average by 4 points in math and 3 points in reading.
- Mrs. Kulp stated that second grade class achieve that was 1 point over the national average in math and 3 points over the national average in reading.
- Mrs. Kulp stated that achievement on mid-year assessments was positive and mist students across the board showed substantial growth,

WHEREAS, since 1994 Colorado's school finance formula has included both a base amount of per pupil funding and additional amount based on "factors" to account for unique local conditions and equalize total per pupil funding across school districts; and

WHEREAS, as November 200 Colorado's voters approved Amendment 23, which requires funding the base and factors at growth plus inflation on a yearly basis; and

141,(G.) <u>Resolution</u>: Restoring the Negative Factor Before Providing TABOR Refunds as a Statewide Priority:

WHERAS, the "negative factor" clearly violates the voter intent of Amendment 23; and

WHEREAS, with the improved economic condition of the State is now leading to increased tax revenue causing there to be much discussion at the state level that Colorado's State Government will soon be in violation of the TABOR Amendment and will thereby by required to refund tax payments to taxpayers; and

WHEREAS, Amendment 23 was passed by voters in Colorado just like the TABOR Amendment was, and so must be complied with;

NOW, THEREFORE BE IT RESOLVED that the Board of Education of the Center Consolidated School District hereby urges the State Legislature, Governor, and Treasurer to honor the intent and language of Amendment 23 by prioritizing the reduction of the Negative Factor ahead of any TABOR refunds and to leave decisions regarding how those funds returned to school districts are spent by locally elected school boards.
