The Board of Education of Center Consolidated School District 26JT in the County of Saguache, State of Colorado, calls for nomination of candidates for school directors to be placed on the ballot for the regular biennial school election to be held on Tuesday, November 5, 2019.

At this election 3 directors will be elected representing the following director districts for a term of office of four years: Director of District C and 2 Directors for Members at Large. A fourth director will be elected representing the following director district for a term of office of two years: Director District A. This two year term will be in place to get the board elections back in compliance with the District Plan of representation as stated in Board Policy BBBG.

To be qualified, a candidate must have been a registered elector of the school district for at least 12 consecutive months before the election and a resident of the director district which will be represented. A person is ineligible to run for school director if he or she has been convicted of committing a sexual offense against a child.

A person who desires to be a candidate for school director shall file a written notice of intention to be a candidate and a nomination petition signed by at least 25 eligible electors who are registered to vote in the regular biennial school election.

Nomination petitions may be obtained at the Center Schools Administration Office, located at 550 S. Sylvester Ave. Center, CO 81125. Office hours are 8:00PM – 4:00PM, Monday through Thursday.

Completed petitions shall be submitted to Alondra Maldonado no later than 4:00PM on August 30, 2019.
