#### PENDLETON COUNTY SCHOOLS EIGHTTEENTH COUNTY BOARD MEETING TUESDAY, MARCH 5, 2019

The Pendleton County Board of Education convened in Regular Session on Tuesday, March 5, 2019, at Pendleton County Middle/High School at 5:30 p.m. The following members were present: J.D. Wilkins - President, Charles Burgoyne, Betty Kimble, Teresa Heavner and Sonny O'Neil. Central Office Staff present: Charles Hedrick, Superintendent, Nicole Hevener, Rick Linaburg, Travis Heavner, Emmy Champ and Lisa Jamison. Others in attendance were: Lori Hull, Tim Johnson, and Shawn Stinson.

At 5:00 p.m., the Board Members and Central Office staff enjoyed a meal prepared and served by the Janice Heavner and her Foods class, the FCCLA, Ron Hudson and the FFA. After dinner the Board, staff members, parents, and students met in the auditorium for a school and student award presentation.

Mr. Matthew Hicks, from the WV State Department of Education began the award ceremony by presenting an award to PCHS for the outstanding graduation rate for 2018. PCHS had the highest graduation rate in the state.

Ms. Hull then welcomed the Board, students and parents to the meeting. She praised the students for their achievements and the parents for their support and participation in their student's education. Ms. Hull, Mr. Johnson and Mr. Hedrick presented Award Certificates to all the PCMHS students who excelled in the WV Summative Assessment tests in the 2017-2018 School year and SAT School Day 2018. One hundred eighteen students were recognized for their skills in ELA and Math.

Ms. Hull then made a presentation to the Board on behalf of the school. She shared how her students have chosen to shine over the last year. Activities mentioned included 2018 Science Fair winners, Grad 20/20 Attendance Reward Winners, middle school science activities and school beautification projects.

She reviewed the 2018-19 Strategic Plan and explained how the school is working to improve instruction through developing lesson plans to meet the needs of the students, as indicated by benchmark data review. She also discussed how IPI has helped them increase student engagement, and how they plan to utilize it and other resources to sustain growth. She shared their new attendance initiative and rewards program that has been a huge success. Their goal is to increase student attendance from 91.774 to 96.75 by the end of the year.

Mr. Tim Johnson spoke on behalf of the LSIC. He discussed their current projects, which included school beautification projects. He discussed a partnership with the Art Department to create a new school logo and school murals as well as an Art Department fundraiser with Community Synergy.

He shared the LSIC goals to engage community support for school improvements, engage students in their community through service projects, provide support for technology, enhance student communication skills, maintain a volunteer program, promote policies and procedures that ensure the safety of students, staff and visitors and investigate opportunities for grant monies to fund school improvements. He noted that the parent satisfaction surveys were distributed at the last parent/teacher conferences and that results would be presented to the Board when they have been tallied.

Ms. Hull shared the status of the schools current projects and goals. They included: improving high traffic areas with new fixtures and paint, improving athletic facilities and upgrades to the auxiliary gym.

In closing, Ms. Hull thanked the Board for their support in obtaining a cooling system in the gym, new cameras, and safety upgrades to the door/fob system. She asked for their continued support for students, teachers, support staff, and administration.
